SUMMARY

(S) THE OSCE MINSK CONFERENCE CO-CHAIRS, DEPUTY SECRETARY TALBOTT, DEPUTY SECRETARY GENERAL BLOT AND AMBASSADOR LOZINSKY, INTRODUCED AND REVIEWED THE CONTENTS OF THE DRAFT COMPREHENSIVE AGREEMENT FOR SETTLEMENT OF THE KARABAKH CONFLICT FOR PRESIDENT TERPETROSSIAN IN YEREVAN ON MAY 31. THE PRESIDENT NOTED PETROSSIAN IN YEREVAN ON MAY 31. THE PRESIDENT NOTED THAT HE HAD "BEEN WAITING FOR A LONG TIME" FOR SUCH A VISIT FROM THE CO-CHAIRS. HE LAMENTED THE LACK OF PROGRESS IN NEGOTIATIONS OVER THE LAST YEAR, CITED THE CEASE-FIRE AS THE ONLY CONCRETE POSITIVE RESULT OF NEGOTIATIONS, AND HOPED THE CO-CHAIRS BROUGHT GOOD NEWS. THE DEPUTY SECRETARY LED OFF FOR THE CO-CHAIRS, STRESSING THE UNITY OF THE THREE GOVERNMENTS IN SUPPORTING THE NEW JOINT APPROACH. FROM THE LEVEL OF SUPPORTING THE NEW JOINT APPROACH. FROM THE LEVEL OF THE CO-CHAIR PRESIDENTS ON DOWN, THE THREE GOVERNMENTS THE CO-CHAIR PRESIDENTS ON DOWN, THE THREE GOVERNMENT HAD WORKED HARD AND TAKEN VERY SERIOUSLY THEIR RESPONSIBILITIES IN MOVING THE PEACE PROCESS FORWARD. THE COMPREHENSIVE AGREEMENT WAS A RESULT OF THE MOST CREATIVE THINKING AND DEDICATION THE CO-CHAIRS COULD IMPART, AND IT WAS THE BEST AGREEMENT THEY COULD PROPOSE. TALBOTT NOTED THE PERSONAL INTEREST OF ALL THREE CO-CHAIR PRESIDENTS IN SEEING THE CONFLICT RESOLVED, AND HOPED THIS INTEREST COULD BE USED TO GIVE AN ADDITIONAL IMPETUS TO THE PEACE TALKS. TALBOTT THEN PRESENTED THE AGREED INTRODUCTORY TALKING POINTS OUTLINED BELOW. BLOT AND LOZINSKY MADE INTRODUCTORY REMARKS ALSO STRESSING CO-CHAIR UNITY AND THE NEED FOR THE DADTIES TO WORK SEPTOMERY. THE PARTIES TO WORK SERIOUSLY AND CONSTRUCTIVELY FOR PEACE. LOZINSKY THEN OUTLINED AGREEMENT ONE, PER AGREED INTRODUCTORY TALKING POINTS. BLOT FOLLOWED,

DOING THE SAME FOR AGREEMENT TWO ON STATUS. AFTER THE PRESENTATION, TER-PETROSSIAN REMARKED THAT THE DOCUMENT WAS EXTENSIVE. HE WANTED TO GIVE A SERIOUS RESPONSE AND SO WOULD DEFER SUBSTANTIVE COMMENTS TO MEETING WITH THE DELECATION THE NEED TO AND SO WOULD DEFER SUBSTANTIVE COMMENTS TO HIS EVENING MEETING WITH THE DELEGATION. THE U.S. DELEGATION WAS LED BY DEPUTY DECRETARY TALBOTT AND INCLUDED S/NIS/RA PRESEL, S/NIS/RA PASCOE, AMBASSADOR TOMSEN, D EDELMAN, S/NIS/RA REMLER AND POLOFF (NOTETAKER). THE FRENCH DELEGATION, LED BY DEPUTY SECRETARY GENERAL BLOT, INCLUDED AMBASSADOR VAUGIER, MFAOFF MANVILLE, MFAOFF PIERRE FILATOFF, AND 2ND SECRETARY DUTERTRE. THE RUSSIAN DELEGATION, LED BY AMBASSADOR LOZINSKY, INCLUDED AMBASSADOR YUKALOV, AMBASSADOR URNOV AND MFAOFF RECHTCHIKOV. PRESIDENTIAL AMBASSADOR URNOV AND MFAOFF RECHTCHIKOV. PRESIDE ADVISOR LIBARIDIAN, FOREIGN MINISTER ARZOUMANIAN, DEPUTY FOREIGN MINISTER OSKANIAN, AND PRESS PRESIDENTIAL SPOKESPERSON ZURABYAN PARTICIPATED FROM THE ARMENIAN SIDE.
- 3. -(S) TER-PETROSSIAN BEGAN BY WELCOMING THE DELEGATION AND NOTING THAT HE HAD BEEN "WAITING A LONG TIME" FOR SUCH A VISIT. HE STATED THAT HE HOPED THE CO-CHAIRS BROUGHT GOOD NEWS, AS THERE HAD BEEN ALMOST NO PROGRESS IN THE NEGOTIATIONS ON KARABAKH FOR MORE THAN A YEAR. THE ONLY THING WE HAVE IS THE CEASE-FIRE, WHICH IS STILL HOLDING, HE COMMENTED. - -- A UNIFIED APPROACH WAS HAMMERED OUT AT THE MAY 15 MEETING OF MINSK CONFERENCE CO-CHAIRMEN IN WASHINGTON.
- --THAT APPROACH IS EMBODIED IN A DRAFT COMPREHENSIVE AGREEMENT THAT REFLECTS THE MOST IMAGINATION AND CREATIVE THINKING THE CO-CHAIRS CAN BRING TO THIS

- --THE DRAFT INCORPORATES THE IDEAS OF ALL THREE CO-CHAIR COUNTRIES, AND REPRESENTS THE BEST AGREEMENT THE CO-CHAIRS CAN PROPOSE.
- --ALL THREE PARTIES WANTED THE CO-CHAIRS TO COME UP WITH A DOCUMENT; THE CO-CHAIRS TOOK THEIR RESPONSIBILITIES SERIOUSLY, AND NOW IT WAS TIME FOR THE PARTIES TO NEGOTIATE SERIOUSLY.
- --THE DOCUMENT WAS BALANCED, DEMANDING EQUAL SACRIFICES FROM EACH SIDE.
- --CHANGES WERE TO BE NEGOTIATED WITH THE OTHER PARTIES, AND THE CO-CHAIRMEN STOOD READY TO HELP FACILITATE SUCH TALKS.
- --THE NUMBER OF NEGOTIATING CHANNELS IS NOT IMPORTANT, BUT THE PARTIES MUST AGREE ON AN AGENDA FOR TALKS.
- --THE CO-CHAIRS SEE TWO AGENDAS FOR TALKS; THE FIRST AGENDA INCLUDES TROOP WITHDRAWALS, RETURN OF DISPLACED PERSONS, A PEACEKEEPING FORCE AND SECURITY MEASURES.
- --THE SECOND AGENDA INVOLVES THE DETERMINATION OF THE STATUS OF NAGORNO-KARABAKH.
- --THE CO-CHAIRS RECOGNIZE THAT IT WILL TAKE COURAGE AND STATESMANSHIP TO SIGN AN AGREEMENT; WE ASK THAT THE PARTIES DO EVERYTHING POSSIBLE TO SHAPE AND LEAD PUBLIC OPINION FOR A SOLUTION BASED ON COMPROMISE.
- --THE AGREEMENT ON STATUS MAY TAKE LONGER TO NEGOTIATE. THEREFORE, THE DOCUMENT IS SEPARATED INTO TWO AGREEMENTS, SO EACH CAN PROCEED AT ITS OWN PACE.
- --THE CO-CHAIRS ARE PREPARED TO ENGAGE IN INTENSIVE SHUTTLE DIPLOMACY ON ALL ISSUES. WE WILL FOCUS, HOWEVER, ON SUBSTANCE, AND NOT MODALITIES OF NEGOTIATIONS. WE WILL HELP REVITALIZE THE MINSK GROUP NEGOTIATIONS AND THE DIRECT CHANNEL. WE HOPE FOR TRANSPARENCY AND SERIOUSNESS FROM THE PARTIES.
- --THE PREAMBLE TO THE COMPREHENSIVE AGREEMENT STRESSES THE BENEFITS OF PEACE FOR THE ENTIRE REGION.
- --THERE ARE STEPS THAT CAN BE TAKEN BEFORE A COMPREHENSIVE AGREEMENT IS REACHED.
- --IN KEEPING WITH COMMENTS MADE BY THE PRESIDENT IN THE INTRODUCTORY REMARKS, THE CO-CHAIRS WILL ASK THAT ALL SIDES EXERCISE MAXIMUM SELF-RESTRAINT IN COMMENTS MADE IN PARLIAMENTARY AND OTHER PUBLIC SETTINGS. THE CURRENT FRAGILE ATMOSPHERE SHOULD NOT BE IRRITATED.
- --WE HAVE INCLUDED.A LIST OF CBMS THAT COULD BE PURSUED IMMEDIATELY, INCLUDING JOINT COMMUNICATIONS TO PREVENT CEASE-FIRE VIOLATIONS LIKE THOSE THAT HAVE BEEN OCCURRING ON THE ARMENIAN-AZERI BORDER.
 --THE CO-CHAIRS REPRESENT THE INTERNATIONAL COMMUNITY'S EFFORTS TO ASSIST PROGRESS TOWARD PEACE. WE ASK THAT YOU GIVE US THE SERIOUS RESPONSE THIS EFFORT DESERVES.
- --DEPENDING ON YOUR RESPONSE, THE THREE CO-CHAIRS ARE PREPARED TO ASK OUR PRESIDENTS TO MEET DURING THE DENVER SUMMIT IN LATE JUNE AND INVOKE THE ATTENTION OF THE INTERNATIONAL COMMUNITY TO GIVE AN ADDITIONAL IMPETUS TO THE SEARCH FOR PEACE.
- 6.—(S) IN HIS INTRODUCTORY REMARKS, DEPUTY SECRETARY, GENERAL BLOT STRESSED THE UNITY OF THE CO-CHAIRMANSHIP. TER-PETROSSIAN QUIPPED THAT THIS WAS ONLY HALF THE PROBLEM -- THERE STILL REMAINS THE PRB LEM OF GETTING AGREEMENT BETWEEN ARMENIA, NAGORNO-KARABAKH AND AZERBAIJAN. - 9. $\overline{\text{(S)}}$ DEPUTY SECRETARY GENERAL BLOT THEN REVIEWED THE TALKING POINTS FOR AGREEMENT TWO ON STATUS. HE NOTED THAT THE AGREEMENT WAS BASED ON DISCUSSIONS IN THE BILATERAL CHANNEL AND ON THE NON-PAPER CIRCULATED BY THE RUSSIANS. THE CO-CHAIRS RECOGNIZED THAT THE SUBJECT OF DISCUSSION IN THE CONFIDENTIAL CHANNEL WAS A TRADE-OFF: TERRITORIAL INTEGRITY FOR STATUS. TER-PETROSSIAN INTERRUPTED TO STATE THAT THERE WERE NEVER ANY CONFIDENTIAL TALKS, SINCE ONE SIDE IN THE TALKS DID NOT TAKE THE CONFIDENTIALITY SERIOUSLY. BLOT PROCEEDED THROUGH THE TALKING POINTS, DISCUSSING THE PRINCIPLES OF TERRITORIAL INTEGRITY AND SELF-DETERMINATION, SECURITY FORCES FOR KARABAKH, THE PROBLEM OF CITIZENSHIP, AND TERRITORIAL CLAIMS. HE CONCLUDED BY STRESSING THAT THE AGREEMENT WAS FOR THE BENEFIT OF THE PARTIES, AND IT WAS UP TO THEM TO NEGOTIATE THE DETAILS. HE STATED THE READINESS OF THE CO-CHAIRS TO PRESERVE THE CONFIDENTIALITY OF THE CONTENTS OF THIS AGREEMENT, AND TO CONDUCT SHUTTLE DIPLOMACY TO ASSIST THE PARTIES IN REACHING AGREEMENT. THE CO-CHAIRS WOULD BE ENERGETIC AND PERSISTENT, BUT THE PARTIES ALONE COULD DETERMINE THEIR FATE.
- (S) AFTER THE CO-CHAIR PRESENTATIONS, TER-PETROSSIAN NOTED THAT THE DOCUMENT WAS EXTENSIVE. OF COURSE, HE WOULD NOT BE ABLE TO SAY ANYTHING SERIOUS REGARDING A REACTION UNTIL HIS EVENING MEETING WITH THE DELEGATION. IF HE REACTED NOW, HE SAID, IT WOULD NOT BE SERIOUS.
- 11. (5) TER-PETROSSIAN WENT ON TO STRESS THE CONFIDENTIALITY OF THE DOCUMENT. "THERE WILL NOT BE ANY REACTION BY PUBLIC OPINION IN THIS CASE," HE STATED. HE NOTED THE IMPORTANCE OF FACE-SAVING IN THE NEGOTIATIONS -- BECAUSE OF THIS, CONFIDENTIALITY WAS ESSENTIAL. HE ASKED WHETHER THIS DOCUMENT WAS CONFIDENTIAL REGARDING THE MINSK GROUP. THE CO-CHAIRS RESPONDED THAT IT WAS.
