Dear Alexandru,

Thank you for your request. Please be informed that the wage-setting procedure for the Chairman of the Board of the Bank of Lithuania is established in the Law on the Bank of Lithuania. The Law defines that the wages of the Chairman of the Board of the Bank of Lithuania are equal to the average five-month wages of the staff of financial intermediation institutions, as published by Statistics Lithuania.

According to the formula defined in the Law, the wages of the Chairman of the Board of the Bank of Lithuania in 2017 amounted to 7 912.81 Eur per month before taxes.
